

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0339

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On July 29, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able to work from July 18, 2021 through July 24, 2021 (week 29-21) and therefore was denied benefits for that week and until the reason for the denial had ended (decision # 90050). On August 18, 2021, decision # 90050 became final without claimant having filed a request for hearing. Claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 19, 2021 issued Order No. 21-UI-177471, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 2, 2021. On October 29, 2021, claimant filed a timely response to the appellant questionnaire. On January 20, 2022, the Office of Administrative Hearings (OAH) mailed claimant a letter stating that Order No. 21-UI-177471 was vacated and a hearing would be scheduled to address whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 90050. On February 25, 2022, ALJ Mott conducted a hearing and issued Order No. 22-UI-187331, dismissing claimant's request for hearing as late without good cause, leaving decision # 90050 undisturbed. On March 12, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-187331 is affirmed.
