# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0346

# Affirmed Late Request for Hearing Dismissed

**PROCEDURAL HISTORY:** On May 26, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits effective December 27, 2020. On June 15, 2021, the May 26, 2021 administrative decision became final without claimant having filed a request for hearing. On October 12, 2021, claimant filed a late request for hearing on the May 26, 2021 administrative decision . ALJ Kangas considered claimant's request, and on December 29, 2021 issued Order No. 21-UI-182961, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 12, 2022. On January 18, 2022, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 21-UI-182961 with the Employment Appeals Board (EAB). On March 15, 2022, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's January 18, 2022 application for review of Order No. 21-UI-182961.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's January 18, 2022 response to the appellant questionnaire and a statement attached thereto, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDINGS OF FACT:** (1) On May 26, 2021, the Department mailed the May 26, 2021 administrative decision to claimant's address on file with the Department. The May 26, 2021 administrative decision stated, "You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received by June 15, 2021." Exhibit 1 at 2.

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The request for hearing on the May 26, 2021 administrative decision was due by June 15, 2021. Because claimant did not file their request for hearing until October 12, 2021, the request was late. On a statement attached to the appellant questionnaire response, claimant stated that "[a]ny dates missed are due to the fact that I moved from Grants Pass to [Portland] in November," and that they were having difficulties focusing due to their mother's hospitalization. EAB Exhibit 1 at 1. Claimant also stated on their questionnaire response that "we moved and I got this letter late," and responded to the question asking when they received the administrative decision by stating that they "just got this letter today 1/15/2[2]." EAB Exhibit 1 at 2. Claimant's responses here appear to refer to their receipt of Order No. 21-UI-182961, which dismissed the May 26, 2021 administrative decision, rather than the May 26, 2021 administrative decision itself. Under ORS 40.135(1)(q), a letter duly directed and mailed is presumed to have been received in the regular course of the mail. The record does not otherwise indicate when claimant received the May 26, 2021 administrative decision, or suggest that they faced some delay in having received it. In the absence of such evidence, it is reasonable to conclude that claimant received the administrative decision sometime during the last week of May 2021 or the first week of June 2021, within a few business days of when it was mailed. In response to the question asking why claimant did not file the request for hearing prior to the deadline, they stated, "Ignorance. I am still not sure how all this works." EAB Exhibit 1 at 3. Claimant did not offer further explanation for why they filed the request for hearing late.

Claimant's responses on the appellant questionnaire do not show that they were delayed in filing the request for hearing due to factors beyond their control. Further, although claimant's failure to file a timely request for hearing was likely the result of a mistake on claimant's part, claimant did not show that it was an "excusable mistake" within the meaning of the administrative rules because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

Therefore, claimant's late request for hearing on the May 26, 2021 administrative decision is subject to dismissal under ORS 657.875 and OAR 471-040-0010.

**DECISION:** Order No. 21-UI-182961 is affirmed.
