

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0367

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On July 6, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of June 13, 2021 through June 19, 2021 (week 24-21) and until the reason for the denial had ended. On July 26, 2021, the July 6, 2021 administrative decision became final without claimant having filed a request for hearing. On October 13, 2021, claimant filed a late request for hearing on the July 6, 2021 administrative decision. ALJ Kangas considered claimant's request, and on November 1, 2021 issued Order No. 21-UI-178624, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 15, 2021. On November 19, 2021, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 21-UI-178624 with the Employment Appeals Board (EAB). On February 22, 2022, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's November 19, 2021 application for review of Order No. 21-UI-178624.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's November 19, 2021 response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) On July 6, 2021, the Department mailed the July 6, 2021 administrative decision to claimant's address on file with the Department. The July 6, 2021 administrative decision

stated, “You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received no later than 07/26/2021.” Exhibit 1 at 1.

CONCLUSIONS AND REASONS: Claimant’s late request for hearing is dismissed.

ORS 657.269 provides that the Department’s decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a “reasonable time” upon a showing of “good cause.” OAR 471-040-0010 (February 10, 2012) provides that “good cause” includes factors beyond an applicant’s reasonable control or an excusable mistake, and defines “reasonable time” as seven days after those factors ceased to exist.

The request for hearing on the July 6, 2021 administrative decision was due by July 26, 2021. Because claimant did not file their request for hearing until October 13, 2021, the request was late. On their appellant questionnaire response, claimant stated that they did not know when they received the July 6, 2021 administrative decision. EAB Exhibit 1 at 1. Claimant also stated on their response that they did not file the request before the deadline because the process was “very confusing” and it was their “first time EVER being on unemployment.” EAB Exhibit 1 at 2 (emphasis in original). Claimant’s explanation does not show that they were unable to file a timely request for hearing due to factors beyond their reasonable control. Further, although claimant’s confusion was likely the cause of a mistake on claimant’s part that led them to file the request for hearing late, it was not an “excusable mistake” within the meaning of the administrative rules because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

Therefore, claimant’s late request for hearing on the July 6, 2021 administrative decision is subject to dismissal under ORS 657.875 and OAR 471-040-0010.

DECISION: Order No. 21-UI-178624 is affirmed.
