

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0373**

*Order No. 22-UI-187141 Affirmed ~ Ineligible Weeks 26-21 and 33-21*  
*Order No. 22-UI-187140 Affirmed ~ Ineligible Weeks 30-21 through 33-21*

**PROCEDURAL HISTORY:** On September 22, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks including June 13, 2021 through August 21, 2021 (weeks 24-21 through 33-21) and therefore was denied benefits for that those weeks (decision # 140138). On September 24, 2021, the Department served notice of an administrative decision concluding that claimant did not actively seek work during the weeks including July 25, 2021 through August 21, 2021 (weeks 30-21 through 33-21) and was therefore ineligible to receive benefits during those weeks (decision # 73811). Claimant filed timely requests for hearing on decisions # 140138 and 73811. On February 4, 2022, the Department served notice of an administrative decision which vacated and replaced decision # 140138 by concluding that claimant filed late claims for unemployment insurance benefits for the weeks including June 27, 2021 through July 3, 2021 (week 26-21) and August 15, 2021 through August 21, 2021 (week 33-21) and therefore was denied benefits for those weeks (decision # 74553).<sup>1</sup> On February 16, 2022, ALJ Murdock conducted a combined hearing on decisions # 74553 and 73811, and on February 24, 2022 issued Orders No. 22-UI-187141 and 22-UI-187140, affirming decisions # 74553 and 73811, respectively. On March 14, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-187141 and 22-UI-187140. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0373 and 2022-EAB-0374).

**WRITTEN ARGUMENT:** Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 22-UI-187141 and 22-UI-187140 are affirmed.
