

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0375

Affirmed

Eligible Weeks 11-21 through 22-21, Ineligible Weeks 23-20 through 10-21

PROCEDURAL HISTORY: On August 3, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's request to backdate her initial claim to May 31, 2020 and concluding that she was therefore ineligible to receive unemployment insurance benefits for the weeks including May 31, 2020 through June 5, 2021 (weeks 23-20 through 22-21) (decision # 63450). Claimant filed a timely request for hearing. On March 8, 2022, ALJ Amesbury conducted a hearing, and on March 10, 2022 issued Order No. 22-UI-188284, modifying decision # 63450 by concluding that claimant was eligible to backdate her initial claim to March 14, 2021 and therefore eligible for benefits for the weeks including March 14, 2021 through June 5, 2021 (weeks 11-21 through 22-21) but was not eligible for benefits for the weeks including May 31, 2020 through March 13, 2021 (weeks 23-20 through 10-21). On March 15, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-188284 is affirmed.
