# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0401

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On February 19, 2021, the Oregon Employment Department (the Department) served notice of a Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits effective February 2, 2020. On March 11, 2021 the February 19, 2021 PUA determination became final without claimant having filed a request for hearing. On September 5, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on December 27, 2021 issued order No. 21-UI-182747, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 10, 2022. On January 18, 2022, Order No. 21-UI-182747 became final without claimant having responded to the appellant questionnaire or filed an application for review of Order No. 21-UI-182747 with the Employment Appeals Board (EAB). On March 23, 2022, claimant filed a late application for review of Order No. 21-UI-182747 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of the written statement included with claimant's application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

**FINDING OF FACT:** (1) Order No. 21-UI-182747, mailed to claimant on December 27, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-182747 at 2. Order No. 21-UI-182747 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than January 18, 2022."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-182747 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-182747 was due January 18, 2022. Because claimant did not file their application for review until March 23, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe circumstances preventing them from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and their late application for review is dismissed.

**DECISION:** The application for review filed March 23, 2022 is dismissed. Order No. 21-UI-182747 remains undisturbed.
