

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0411

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On December 24, 2020, the Oregon Employment Department (the Department) served notice of a Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits effective May 31, 2020. On January 13, 2021, the PUA determination became final without claimant having filed a request for hearing. On February 9, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on March 8, 2021 issued Order No. 21-UI-162281, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 22, 2021. Claimant filed a timely response to the appellant questionnaire. The Office of Administrative Hearings (OAH) considered the response, and on May 28, 2021 mailed a letter stating that Order 21-UI-162281 was canceled and that a hearing would be scheduled to address the timeliness of claimant's hearing request and, if appropriate, the merits of the December 24, 2020 PUA determination.

On November 29, 2021, OAH served notice that the hearing was scheduled for December 17, 2021 at 8:15 a.m. On December 17, 2021, claimant failed to appear at the 8:15 a.m. hearing, and on December 23, 2021 ALJ Monroe issued Order No. 21-UI-182589, re-dismissing claimant's request for hearing on the December 24, 2020 PUA determination due to claimant's failure to appear at the hearing. On December 28, 2021, claimant filed a timely request to reopen the hearing. ALJ Kangas considered claimant's request, and March 23, 2022 issued Order No. 22-UI-189487, denying the request. On March 27, 2022, claimant filed an application for review of 22-UI-189487 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information regarding their failure to appear at the December 17, 2021 hearing that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information into the hearing record with their request to reopen the hearing, as required under OAR 471-040-0040(3) (February 10, 2012). Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-189487 is affirmed.
