

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0425**

*Affirmed*  
*Late Requests to Reopen Dismissed*

**PROCEDURAL HISTORY:** On November 12, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits effective March 15, 2020 because he was discharged for misconduct by Virtual Supply (decision # 82456). On December 2, 2020, decision # 82456 became final without claimant having filed a request for hearing. On February 16, 2021, the Department served notice of a Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits effective March 15, 2020 (PUA determination). On February 25, 2021, claimant filed a late request for hearing on decision # 82456, and a timely request for hearing on the PUA determination.

On August 19, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing regarding claimant's late request for hearing on decision # 82456, and notice of a hearing on the PUA determination, scheduled for September 9, 2021. On September 9, 2021, claimant failed to appear at the hearings, and ALJ Janzen issued Orders No. 21-UI-174406 and 21-UI-174423, dismissing claimant's requests for hearings on decision # 82456 and the PUA determination for failure to appear. On September 29, 2021, Orders No. 21-UI-174406 and 21-UI-174423 became final without claimant having filed a request to reopen the hearings.

On December 15, 2021, claimant filed late requests to reopen the hearings. ALJ Kangas considered claimant's requests, and on March 8, 2022 issued Orders No. 22-UI-188128 and 22-UI-188127, dismissing the requests as late without a showing of good cause. On March 28, 2022, claimant filed applications for review of Orders No. 22-UI-188128 and 22-UI-188127 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-188128 and 22-UI-188127. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0424 and 2022-EAB-0425).

**WRITTEN ARGUMENT:** Claimant's argument contained information that was not part of the hearing records, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information into the hearing records with his late requests to reopen, as required

under OAR 471-040-0041(4) (February 10, 2012). Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into the hearing records when reaching this decision.

EAB reviewed both hearing records in their entirety. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 22-UI-188128 and 22-UI-188127 are affirmed.
