# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0431

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On June 21, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks including December 27, 2020 through February 20, 2021 and therefore was ineligible to receive benefits for those weeks (decision # 143030). On July 26, 2021 claimant filed a late request for hearing on the June 21, 2021 administrative decision. On August 13, 2021, ALJ Kangas issued Order No. 21-UI-172556 dismissing claimant's request for hearing as untimely without a showing of good cause subject to claimant responded to the appellant questionnaire. On August 23, 2021 claimant responded to the appellant questionnaire. On January 11, 2022, the Office of Administrative Hearings (OAH) issued a letter stating that Order No. 21-UI-172556 was cancelled. On February 9, 2022, OAH mailed notice of a hearing scheduled for February 22, 2022. On February 22, 2022, ALJ L. Lee conducted a hearing, and on March 2, 2022 mistakenly reissued Order No. 22-UI-172556. On March 3, 2022, OAH issued Order No. 22-UI-187789, affirming the June 21, 2021 administrative decision. On March 23, 2022, Order No. 22-UI-187789 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On

**FINDINGS OF FACT:** (1) Order No. 22-UI-187789, mailed to claimant on March 3, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-187789 at 4. Order No. 22-UI-187789 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before March 23, 2022 to be timely."

(2) On April 4, 2022, claimant filed an application for review of Order No. 22-UI-187789.

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 22-UI-187789 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a

showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-187789 was due March 23, 2022. Because claimant did not file their application for review until April 4, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the March 23, 2022 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed April 4, 2022 is dismissed. Order No. 22-UI-187789 remains undisturbed.
