

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0432

Affirmed
Not Disqualified from Receiving Benefits
Eligible for Benefits for School Recess Period

PROCEDURAL HISTORY: On April 23, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied unemployment insurance benefits beginning March 28, 2021 because she quit working for the employer without good cause (decision # 142729). On April 26, 2021, claimant filed a timely request for hearing on decision # 142729. On July 7, 2021, the Department served notice of an administrative decision concluding that claimant was denied benefits for the week of June 20 through 26, 2021 because she was not eligible for benefits for benefits during the June 16 through September 6, 2021 break between two academic years (decision # 133540). On July 13, 2021, claimant filed a timely request for hearing on decision # 133540. On March 30, 2022, ALJ Janzen conducted a consolidated hearing on decisions # 142729 and 133540. On March 31, 2022, ALJ Janzen issued Order No. 22-UI-190146 reversing decision # 142729 by concluding that claimant quit working for the employer with good cause and was not disqualified from receiving benefits based on the work separation, and Order No. 22-UI-190147 reversing decision # 133540 by concluding that claimant was eligible for benefits during the June 16 through September 6, 2021 break between two academic years.

On April 4, 2022, the employer filed an application for review of Orders No. 22-UI-190146 and 22-UI-190147 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-190146 and 22-UI-190147. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 22-EAB-0432 and 22-EAB-0433).

EAB reviewed the hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 22-UI-190146 and 22-UI-190147 are affirmed.
