

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0435**

*Affirmed*  
*Late Claims for Weeks 53-20 through 15-21 Denied*

**PROCEDURAL HISTORY:** On May 20, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the weeks from October 11, 2020 through April 17, 2021 (weeks 42-20 through 15-21) because her claims for those weeks were late (decision # 83959). Claimant filed a timely request for hearing on decision # 83959. On January 3, 2022 the Department served notice of a decision that replaced and invalidated decision # 83959, concluding that claimant was denied benefits for the weeks from December 27, 2020 through April 17, 2021 (weeks 53-20 through 15-21) because her claims for those weeks were late (decision # 120100). Claimant filed a timely request for hearing on decision # 120100. On March 17, 2022, ALJ Mott conducted a hearing and issued Orders No. 22-UI-189002 and 22-UI-189001, concluding that claimant was denied benefits for weeks 53-20 through 15-21 because her claims for those weeks were late.

On April 4, 2022, claimant filed applications for review of Orders No. 22-UI-189002 and 22-UI-189001 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. Orders No. 22-UI-189002 and 22-UI-189001. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0434 and 2022-EAB-0435). EAB considered claimant's written argument when reaching this decision.

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Order No. 22-UI-189002 and 22-UI-189001 are affirmed.
