

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0441**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On January 24, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective October 17, 2021 (decision # 140205). Claimant filed a timely request for hearing. On March 14, 2022, ALJ Lucas conducted a hearing, and on March 16, 2022 issued Order No. 22-UI-188762, modifying decision # 140205 by concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving benefits effective November 14, 2021.<sup>1</sup> On April 5, 2022, claimant filed an application for review of Order No. 22-UI-188762 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-188762 is affirmed.
