

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0442

Affirmed
Late Request to Reopen Dismissed

PROCEDURAL HISTORY: On December 22, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits effective June 21, 2020 because she quit working for the employer without good cause (decision # 131514). On January 11, 2021, decision # 131514 became final without claimant having requested a hearing. On March 24, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on April 22, 2021 issued Order No. 21-UI-165358, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 6, 2021. Claimant filed a timely response to the appellant questionnaire.

On August 3, 2021, the Office of Administrative Hearings (OAH) served notice of hearing scheduled for August 16, 2021 on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 131514. On August 16, 2021, claimant failed to appear at the hearing, and ALJ Logan issued Order No. 21-UI-172646, dismissing claimant's request for hearing for failure to appear. On September 7, 2021, Order No. 21-UI-172646 became final without claimant having filed a request to reopen the hearing. On December 3, 2021, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request, and on March 22, 2022 issued Order No. 22-UI-189413, dismissing the request as late without a showing of good cause. On April 4, 2022, claimant filed an application for review of Order No. 22-UI-189413 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-189413 is affirmed.
