

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0453

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On March 25, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits effective February 21, 2021 because he quit working for the employer without good cause (decision # 142419). Claimant filed a timely request for hearing. On November 18, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for December 2, 2021. On December 2, 2021, claimant failed to appear at the hearing, and ALJ Scott issued Order No. 21-UI-180935, dismissing claimant's request for hearing for failure to appear. On December 21, 2021, claimant filed a request to reopen the hearing. ALJ Kangas reviewed claimant's request, and on March 23, 2022 issued Order No. 22-UI-189475, denying the request. On April 7, 2022, claimant filed an application for review of Order No. 22-UI-189475 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information into the hearing record with his request to reopen, as required under OAR 471-040-0040(3) (February 10, 2012). Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into the hearing record when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-189475 is affirmed.
