EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0468

Affirmed
Late Request For Hearing Dismissed

PROCEDURAL HISTORY: On February 11, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 2, 2020. On March 3, 2021 the February 11, 2021 administrative decision became final without claimant having filed a timely request for hearing. On November 19, 2021 claimant filed a late request for hearing on the February 11, 2021 administrative decision. On November 29, 2021 ALJ Kangas issued Order No. 21-UI-180562 dismissing claimant's request for hearing as untimely without a showing of good cause subject to claimant's right to renew the request by responding to appellant questionnaire. On December 6, 2021 claimant responded to the appellant questionnaire. On March 2, 2022 the Office of Administrative Hearings (OAH) issued a letter stating that Order No. 21-UI-180562 was cancelled. On March 17, 2022, OAH mailed notice of a hearing scheduled for April 1, 2022. On April 1, 2022, ALJ Murdock conducted a hearing, and on April 7, 2022 issued Order No. 22-UI-190832, re-dismissing claimant's late request for hearing as late without good cause and leaving the February 11, 2021 administrative decision undisturbed. On April 13, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-190832 is affirmed.
