

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0471**

*Affirmed*  
*Late Request for Hearing Allowed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On November 10, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective April 12, 2020 (decision # 100305). On November 30, 2020, decision # 100305 became final without claimant having filed a request for hearing. On January 11, 2021, claimant filed a late request for hearing. On March 31, 2022,<sup>1</sup> ALJ Demarest conducted a hearing at which the employer failed to appear, and on April 6, 2022, ALJ Demarest issued Order No. 22-UI-190692, allowing claimant's late request for hearing and reversing decision # 100305 by concluding that claimant voluntarily quit work with good cause and was not disqualified from receiving benefits based on the work separation. On April 14, 2022, the employer filed an application for review with the Employment Appeals Board (EAB).<sup>2</sup>

**WRITTEN ARGUMENT:** The employer did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

<sup>2</sup> Pursuant to OAR 471-041-0060(5) (effective May 13, 2019), EAB treated the employer's application for review as an application for review rather than a request to reopen the hearing because the application for review did not include a written statement that set forth the reason(s) for the employer's failure to appear at the March 31, 2022 hearing as required under OAR 471-040-0040(3) (effective February 10, 2012).

**DECISION:** Order No. 22-UI-190692 is affirmed.
