EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0491

Affirmed Request to Reopen Denied

PROCEDURAL HISTORY: On April 21, 2021, the Oregon Employment Department (the Department) served notice of five administrative decisions concluding that claimant was denied unemployment insurance benefits for the weeks of October 4, 2020 through 10, 2020 (decision #82250), November 1, 2020 through 7, 2020 (decision #82118), November 15, 2020 through 21, 2020 (decision #81923), January 10, 2021 through 16, 2021 (decision 81751), and January 31, 2021 through February 6, 2021 (decision #81613) because claimant filed late claims for benefits for those weeks. Claimant filed timely requests for hearing on decisions #82250, 82118, 81923, 81751, and 81613.

On November 29, 2021, the Office of Administrative Hearings (OAH) mailed a notice of a consolidated hearing on decisions #82250, 82118, 81923, 81751, and 81613 scheduled for December 14, 2021. On December 14, 2021 claimant failed to appear at the hearing, and ALJ Ramey issued Orders No. 21-UI-181856, 21-UI-181884, 21-UI-181883, 21-UI-181854 and 21-UI-181846, dismissing claimant's requests for hearing on decisions #82250, 82118, 81923, 81751, and 81613 for failure to appear. On January 1, 2022 claimant filed a request to reopen the hearing. ALJ Kangas considered claimant's request, and on March 29, 2022 issued Orders No. 22-UI-189963, 22-UI-189965, 22-UI-189966, 22-UI-189967 and 22-UI-189969, denying the request. On April 18, 2022, claimant filed timely applications for review of Orders No. 22-UI-189963, 22-UI-189965, 22-UI-189967 and 22-UI-189969 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-189963, 22-UI-189965, 22-UI-189966, 22-UI-189967 and 22-UI-189969. For case-tracking purposes, this decision is being issued in quintuplicate (EAB Decisions 2022-EAB-0488, 2022-EAB-0489, 2022-EAB-0490, 2022-EAB-0491 and 2022-EAB-0492).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written argument claimant submitted with her application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of

our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDINGS OF FACT: (1) Claimant missed the December 14, 2021 hearing because she did not double check her calendar for the hearing date. EAB Exhibit 1.

CONCLUSIONS AND REASONS: Claimant's request to reopen the December 14, 2021 hearing is denied.

ORS 657.270(5) provides that any party who failed to appear at a hearing may request to reopen the hearing, and the request will be allowed if it was filed within 20 days of the date the hearing decision was issued and shows good cause for failing to appear. The period within which a party may request reopening may be extended if the party requesting reopening has good cause for failing to request reopening within the time allowed, and acts within a reasonable time. OAR 471-040-0041(1) (February 10, 2012). "Good cause" exists when an action, delay, or failure to act arises from an excusable mistake or from factors beyond an applicant's reasonable control. OAR 471-040-0041(2).

Claimant did not show good cause to file a late request to reopen the December 14, 2021 hearing. In her request to reopen, claimant explained, "I initially read and understood my scheduled hearing was December 14, but with the stresses of the holiday season and my health, I did not double check my calendar for the hearing date." EAB Exhibit 1. However, although the stresses of the holiday season and claimant's health may have been factors beyond claimant's reasonable control, claimant failed to show that those factors prevented her from double-checking her calendar for the hearing date and appearing on that date. And although claimant's failure to appear at the hearing was the result of a mistake on her part, it was not an "excusable mistake" within the meaning of the administrative rules because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

Because claimant failed to establish good cause for failing to appear at the December 14, 2021 hearing, her request to reopen the hearing is denied.

DECISION: Orders No. 22-UI-189963, 22-UI-189965, 22-UI-189966, 22-UI-189967 and 22-UI-189969 are affirmed.
