

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0503**

*Affirmed*  
*Overpayment Assessed*

**PROCEDURAL HISTORY:** On December 14, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which they were not entitled, and assessing an overpayment of \$1,800 in Lost Wages Assistance (LWA) benefits that claimant was required to repay to the Department (decision # 0563988). Claimant filed a timely request for hearing. On April 12, 2022, ALJ Kaneshiro conducted a hearing, and issued Order No. 22-UI-191153, affirming decision # 0563988.<sup>1</sup> On April 25, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB considered claimant's argument when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-191153 is affirmed.
