EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0507-R

Late Request for Reconsideration Dismissed

PROCEDURAL HISTORY: On August 23, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not able, available, and actively seeking work and was therefore disqualified from receiving unemployment insurance benefits effective March 15, 2020 through July 31, 2021 (weeks 12-20 through 30-21) and until the reason for the denial had ended (decision # 150213). On September 13, 2021, decision # 150213 became final without claimant having filed a request for hearing. On October 22, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on November 17, 2021 issued Order No. 21-UI-179862, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 1, 2021. On December 4, 2021, claimant filed a timely response to the appellant questionnaire. On March 8, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 21-UI-179862 dismissing claimant's hearing request was vacated and that a new hearing would be scheduled to determine whether claimant had good cause to file the late request for hearing and, if so, the merits of decision # 150213. On March 29, 2022, ALJ S. Lee conducted a hearing, and on April 7, 2022 issued Order No. 22-UI-190817, dismissing claimant's request for hearing as late without a showing of good cause, and leaving decision # 150213 undisturbed. On April 26, 2022, claimant filed an application for review with the Employment Appeals Board (EAB). On May 27, 2022, EAB issued EAB Decision 2022-EAB-0507, affirming Order No. 22-UI-190817. On October 13, 2022, claimant filed a request for reconsideration with EAB.

This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's request for reconsideration is dismissed. EAB Decision 2022-EAB-0507 remains undisturbed.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment

Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2) (May 13, 2019).

On May 27, 2022, EAB issued EAB Decision 2022-EAB-0507. Claimant did not file his request for reconsideration with EAB until October 13, 2022. Accordingly, claimant's request for reconsideration was filed more than 20 days after the decision was mailed and is late. OAR 471-041-0145(2) contains no exception to the requirements that a request for reconsideration must be filed on or before the 20th day after the decision sought to be reconsidered was mailed. Claimant's request for reconsideration therefore is dismissed.

DECISION: Claimant's request for reconsideration is dismissed. Order No. 22-UI-190817 remains undisturbed.
