

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0512

Affirmed
Ineligible Week 28-20

PROCEDURAL HISTORY: On March 2, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work during the week including July 5, 2020 through July 11, 2020 (week 28-20) and was therefore not eligible to receive unemployment insurance benefits for that week (decision # 75048). Claimant filed a timely request for hearing. On April 26, 2022, ALJ Griffin conducted a hearing and issued Order No. 22-UI-192219, affirming decision # 75048. On April 28, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-192219 is affirmed.
