EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0514-R

*Request for Reconsideration Dismissed
EAB Decision 2022-EAB-0514 Remains Undisturbed*

PROCEDURAL HISTORY: On March 11, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits beginning October 24, 2021 (decision # 122911). Claimant filed a timely request for hearing. On April 21, 2022, ALJ S. Roberts conducted a hearing, and on April 26, 2022 issued Order No. 22-UI-192152, reversing decision # 122911 by concluding that claimant quit work with good cause and was not disqualified from receiving benefits based on the work separation. On April 29, 2022, the employer filed an application for review with the Employment Appeals Board (EAB). On July 13, 2022, EAB issued EAB Decision 2022-EAB-0514, affirming Order No. 22-UI-192152. On August 2, 2022, the employer filed a request for reconsideration of EAB Decision 2022-EAB-0514.

This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: The employer's request for reconsideration is dismissed.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB issued EAB Decision 2022-EAB-0514 on July 13, 2022. The employer filed their request for reconsideration on August 2, 2022. Therefore, the employer's request for reconsideration is timely. However, the employer's request for reconsideration did not include a statement that the employer provided a copy of the request for reconsideration to the claimant as required. The employer's request is therefore dismissed.

DECISION: The application for review filed August 2, 2022 is dismissed. Order No. 22-UI-192152 remains undisturbed.
