

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0529**

*Order No. 22-UI-189405 Late Application for Review Dismissed*  
*Order No. 22-UI-192035 Affirmed ~ Overpayment Assessed*

**PROCEDURAL HISTORY:** On May 26, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective August 30, 2020 (decision # 95142). On June 15, 2021, decision # 95142 became final without claimant having filed a request for hearing. On December 3, 2021, the Department served notice of an administrative decision concluding that claimant was overpaid \$300.00 in Lost Wages Assistance benefits (decision # 559273). On December 29, 2021, claimant filed a late request for hearing on decision # 95142. Also on December 29, 2021, claimant filed a late request for hearing on decision # 559273, which the Office of Administrative Hearings (OAH) treated as timely. ALJ Kangas considered claimant's request for hearing on decision # 95142, and on March 22, 2022 issued Order No. 22-UI-189405, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 5, 2022. On April 11, 2022, Order No. 22-UI-189405 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On April 18, 2022, ALJ Blam-Linville conducted a hearing on decision # 559273, and on April 25, 2022 issued Order No. 22-UI-192035 affirming decision # 559273. On April 28, 2022, claimant filed a late application for review of Order No. 22-UI-189405 with EAB. On April 30, 2022, claimant filed an application for review of Order No. 22-UI-192035 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-189405 and 22-UI-192035. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0513 and 2022-EAB-0529).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), Order No. 22-UI-192035 is **adopted**.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their application for review of Order No. 22-UI-189405, and has been marked as EAB

Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 22-UI-189405, mailed to claimant on March 22, 2022, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 22-UI-189405 at 2. Order No. 22-UI-189405 also stated on its Certificate of Mailing, “Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board not later than April 11, 2022.”

**CONCLUSIONS AND REASONS:** Claimant’s late application for review of Order No. 22-UI-189405 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-189405 was due April 11, 2022. Because claimant did not file their application for review until April 28, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, claimant’s written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

**DECISION:** The application for review filed April 28, 2022 is dismissed. Order No. 22-UI-189405 remains undisturbed. Order No. 22-UI-192035 is affirmed.
