

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0541**

*Affirmed*  
*Ineligible Weeks 23-20 and 24-20*

**PROCEDURAL HISTORY:** On December 4, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits from May 24 through June 13, 2020, July 5 through 18, 2020, and November 1 through 28, 2020 because he was unable to work during that period (decision # 140323). On December 7, 2020, claimant filed a timely request for hearing on decision # 140323. On April 12, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for April 25, 2022. On April 15, 2022, the Department served notice of an administrative decision replacing and invalidating decision # 140323, concluding that claimant was denied benefits from May 31 through June 13, 2020 because he was unable to work during that period (decision # 65010). On April 25, 2022, ALJ M. Davis conducted a hearing on decision # 65010 and issued Order No. 22-UI-192144, affirming that decision. On May 7, 2022, claimant filed an application for review of Order No. 22-UI-192144 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-192144 is affirmed.
