EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0551

Application for Review Dismissed No Justiciable Controversy

PROCEDURAL HISTORY AND FINDINGS OF FACT: On June 10, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 2, 2020. Claimant filed a timely request for hearing. On April 14, 2022, ALJ Janzen conducted a hearing, and on April 19, 2022 issued Order No. 22-UI-191626, reversing the June 10, 2021 administrative decision by concluding that claimant was entitled to receive PUA benefits for the weeks including March 21, 2021 through March 27, 2021, April 4, 2021 through May 29, 2021, and June 20, 2021 through July 17, 2021 (weeks 12-21, 14-21 through 21-21, and 25-21 through 28-21). On May 10, 2022, claimant filed an application for review with the Employment Appeals Board (EAB). On May 20, 2022, ALJ Janzen served notice of Order No. 22-UI-194253, amending Order No. 22-UI-191626 by concluding that claimant was entitled to receive PUA benefits for the weeks including March 15, 2020 through March 27, 2021, April 4, 2021 through May 29, 2021, and June 20, 2021 through July 17, 2021 (weeks 12-20 through 12-21, 14-21 through 21-21, and 25-21 through 28-21).

WRITTEN ARGUMENT: EAB considered claimant's written argument in reaching this decision.

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 22-UI-191626 presents no justiciable controversy and is dismissed.

On May 10, 2022, claimant filed with EAB an application for review of Order No. 22-UI-191626, an order that granted claimant PUA benefits for weeks 12-21, 14-21 through 21-21, and 25-21 through 28-21). Order No. 22-UI-191626 did not grant claimant benefits for the weeks including March 15, 2020 through March 20, 2021 (weeks 12-20 through 11-21) due to a scrivener's error. However, on May 20, 2022, ALJ Janzen of the Office of Administrative Hearings issued Order No. 22-UI-194253, which concluded claimant was entitled to receive PUA benefits for weeks 12-20 through 12-21, 14-21 through 21-21, and 25-21 through 28-21. Claimant did not assign error to any portion of that order, did not request reversal of any portion of that order, and alleged no facts entitling claimant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review of Order No. 22-UI-191626. See accord Barcik v. Kubiacyk, 321 Or 174, 895 P2d

765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 22-UI-191626 is dismissed.

DECISION: The application for review filed May 10, 2022 is dismissed. Order No. 22-UI-194253, amending Order No. 22-UI-191626, remains undisturbed.
