

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0555**

*Affirmed*  
*Late Request to Reopen Denied*

**PROCEDURAL HISTORY:** On December 15, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able to work or available for work during the weeks from July 12, 2020 through September 12, 2020 (weeks 29-20 through 37-20) and was therefore ineligible for unemployment insurance benefits for those weeks (decision # 122115). Claimant filed a timely request for hearing. On October 12, 2021, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for October 25, 2021 at 8:15 a.m. On October 25, 2021, claimant failed to appear at the hearing, and ALJ A. Mann issued Order No. 21-UI-177952, dismissing claimant's request for hearing for failure to appear. On November 15, 2021, Order No. 21-UI-177952 became final without claimant having filed a request to reopen the hearing. On February 25, 2022, claimant filed a late request to reopen the hearing.<sup>1</sup> ALJ Kangas considered claimant's request, and on May 4, 2022 issued Order No. 22-UI-192904, dismissing the request as late without good cause, and leaving Order No. 21-UI-177952 undisturbed. On May 10, 2022, claimant filed an application for review of Order No. 22-UI-192904 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-192904 is affirmed.

<sup>1</sup> Claimant's request on February 25, 2022 suggests they also may have sought to appeal a different administrative decision (# 162042, which denied claimant's request for a waiver of an overpayment of benefits that the Department had assessed). Exhibit 5 at 2. However, EAB's jurisdiction is limited to the issue on appeal here, the dismissal of claimant's late request to reopen the October 25, 2021 hearing on decision # 122115. This decision addresses only that issue.
