EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0557

Late Application for Review Dismissed

PROCEDURAL HISTORY: On October 29, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective September 19, 2021 (decision # 131020). Claimant filed a timely request for hearing. On March 31, 2022, ALJ Scott conducted a hearing and issued Order No. 22-UI-190205, affirming decision # 131020. On April 20, 2022, Order No. 22-UI-190205 became final without the claimant having filed an application for review with the Employment Appeals Board (EAB). On May 11, 2022, claimant filed a late application for review of Order No. 22-UI-190205 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their application for review of Order No. 22-UI-190205, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Order No. 22-UI-190205, mailed to claimant on March 31, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-190205 at 3. Order No. 22-UI-190205 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before April 20, 2022 to be timely."

(2) Claimant received Order No. 22-UI-190205 in the mail on April 21, 2022. Claimant filed their application for review of Order No. 22-UI-190205 by mail on May 11, 2022.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-190205 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-190205 was due by April 20, 2022. Because claimant did not file their application for review until May 11, 2022, the application for review was late. Claimant's application for review included a written argument stating that claimant did not receive Order No. 22-UI-190205 until April 21, 2022. EAB Exhibit 1 at 1. This could constitute a factor beyond claimant's reasonable control. However, claimant did not file the application for review within seven days of when they received the Order, which would have been April 28, 2022. Because claimant did not file their application for review within a reasonable time after the circumstances that prevented a timely ceased to exist, claimant's late application for review is dismissed.

DECISION: The application for review filed May 11, 2022 is dismissed. Order No. 22-UI-190205 remains undisturbed.
