

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0565**

*Order No. 22-UI-193458 ~ Affirmed (Eligible Weeks 39-21 through 10-22 and Ineligible Weeks 11-22 through 17-22)*

*Order No. 22-UI-193486 ~ Affirmed (Ineligible Weeks 41-21 through 17-22)*

**PROCEDURAL HISTORY:** On October 18, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from September 26, 2021 through October 9, 2021 (weeks 39-21 through 40-21) and therefore was not eligible for unemployment insurance benefits for those weeks and until the reason for the denial had ended (decision # 83307). On November 2, 2021, the Department served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible for benefits for the week of October 10, 2021 through October 16, 2021 (week 41-21) and until the reason for the denial had ended. Claimant filed timely requests for hearing on decision # 83307 and the November 2, 2021 administrative decision.

On May 11, 2022, ALJ Griffin conducted hearings on the administrative decisions and issued Order No. 22-UI-193458 modifying decision # 83307 by concluding that claimant was available for work and therefore eligible for benefits from September 26, 2021 through March 12, 2022 (weeks 39-21 through 10-22) but was not available for work and therefore ineligible for benefits from March 13, 2022 through April 30, 2022 (weeks 11-22 through 17-22). Also on May 11, 2022, ALJ Griffin issued Order No. 22-UI-193486, modifying the November 2, 2021 administrative decision by concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible for benefits from October 10, 2021 through April 30, 2022 (weeks 41-21 through 17-22). On May 14, 2022, claimant filed applications for review of Orders No. 22-UI-193458 and 22-UI-193486 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-193458 and 22-UI-193486. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0566 and 2022-EAB-0565).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Orders No. 22-UI-193458 and 22-UI-193486 are affirmed.
