

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0592**

*Affirmed*  
*Late Requests for Hearing Dismissed*

**PROCEDURAL HISTORY:** On October 19, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective March 1, 2020 (decision # 74110). On November 8, 2021, decision # 74110 became final without claimant having filed a request for hearing. On December 2, 2021, the Department served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report material facts to obtain benefits, and assessing a \$55,033 overpayment of unemployment insurance benefits, a \$15,969.90 monetary penalty, and 52 penalty weeks. On December 22, 2021, the December 2, 2021 administrative decision became final without claimant having filed a timely request for hearing. On April 1, 2022, claimant filed late requests for hearings on decision # 74110 and the December 2, 2021 administrative decision.

On April 13, 2021, the Office of Administrative Hearings (OAH) served notice of hearings on May 2, 2022 to consider claimant's late requests for hearings on decision # 74110 and the December 2, 2021 administrative decision and, if allowed, the merits of those decisions. On May 2, 2022, ALJ Frank conducted both hearings, and on May 10, 2022 issued Orders No. 22-UI-193323 and 22-UI-193322, dismissing claimant's requests for hearing as late without a showing of good cause, and leaving decisions # 74110 and the December 2, 2021 administrative decision undisturbed. On May 21, 2022,

claimant filed applications for review of Orders No. 22-UI-193323 and 22-UI-193322 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-193323 and 22-UI-193322. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0592 and 2022-EAB-0591).

EAB reviewed the entire hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 22-UI-193323 and 22-UI-193322 are affirmed. Decision # 74110 and the December 2, 2021 administrative decision remain undisturbed.
