

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0595**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On October 5, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the weeks from January 3 through May 8, 2021 because she claimed benefits for those weeks late (decision # 82536). Claimant filed a timely request for hearing. On April 8, 2022, ALJ Lucas conducted a hearing, and on April 14, 2022 issued Order No. 22-UI-191355, affirming decision # 82536. On May 4, 2022, Order No. 22-UI-191355 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On May 17, 2022, claimant filed a late application for review with EAB.

**FINDING OF FACT:** Order No. 22-UI-191355, mailed to claimant on April 14, 2022, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 22-UI-191355 at 2. Order No. 22-UI-191355 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before May 4, 2022 to be timely.”

**CONCLUSIONS AND REASONS:** Claimant’s late application for review of Order No. 22-UI-191355 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-191355 was due May 4, 2022. Because claimant did not file their application for review until May 17, 2022, the application for review was late. Claimant’s

application for review did not include a written statement describing circumstances that prevented claimant from filing the application for review by the May 4, 2022 deadline. Accordingly, claimant did not show good cause for the late application for review, and their late application for review is dismissed.

**DECISION:** The application for review filed May 17, 2022 is dismissed. Order No. 22-UI-191355 remains undisturbed.
