

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0605

Affirmed
Late Claims for Benefits Denied
Ineligible Weeks 37-20 through 28-21

PROCEDURAL HISTORY: On August 4, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks including September 6, 2020 through July 17, 2021 (weeks 37-20 through 28-21) and therefore was ineligible to receive benefits for those weeks (decision # 72655). Claimant filed a timely request for hearing. On August 18, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for September 1, 2021 at 9:30 a.m. On September 1, 2021, claimant failed to appear at the hearing, and ALJ Frank issued Order No. 21-UI-173790, dismissing claimant's request for hearing due to her failure to appear and leaving decision # 72655 undisturbed.

On September 12, 2021, claimant filed a timely request to reopen the September 1, 2021 hearing. On March 30, 2022, OAH served notice of a hearing scheduled for April 14, 2022 to address whether claimant had good cause to reopen the September 1, 2021 hearing and, if so, the merits of decision # 72655. On April 14, 2022, ALJ Monroe conducted a hearing, and on May 23, 2022, issued Order No. 22-UI-194334 granting claimant's request to reopen the September 1, 2021 hearing, and affirming decision # 72655. On May 26, 2022, claimant filed an application for review of Order No. 22-UI-194334 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-194334 is affirmed.
