

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0608**

*Affirmed*  
*Ineligible for PUA Benefits Weeks 01-21 through 18-21*

**PROCEDURAL HISTORY:** On September 23, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective March 1, 2020. Claimant filed a timely request for hearing. On May 11, 2022, ALJ Scott conducted a hearing and served Order No. 22-UI-193442, modifying the September 23, 2021 PUA determination by concluding that claimant was not entitled to receive PUA benefits for the weeks from January 3, 2021 through May 8, 2021 (weeks 01-21 through 18-21). On May 25, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** In claimant's written argument, claimant pointed out that she claimed PUA benefits for some of the weeks for which she was ineligible to receive benefits because a Department representative urged her to do so. Claimant's Written Argument. In light of this, claimant stated that it would be unjust for an overpayment to be assessed against her and requested a "Judgement in which I am not responsible for an overpayment." Claimant's Written Argument. Because the September 23, 2021 PUA determination and the order under review were limited in scope to claimant's eligibility for PUA benefits, addressing claimant's eligibility for a waiver of any overpayment is beyond the scope of this appeal. However, claimant may wish to request the Department grant her a federal waiver of any overpayment of PUA benefits she received. The Department may defer recovery or completely waive the overpaid amount if certain standards are met. EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-193442 is affirmed.
