EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0628

Late Application for Review Dismissed

PROCEDURAL HISTORY: On August 12, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied unemployment insurance benefits for the weeks of July 4, 2021 through 31, 2021 because claimant's request to backdate her claimant to July 4, 2021 was late (decision #134424). On September 1, 2021, decision #134424 became final without claimant having filed a request for hearing. On December 3, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on March 16, 2022 issued Order No. 22-UI-188845, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 30, 2022. On April 5, 2022, Order No. 22-UI-188845 became final without claimant having responded to the appellant questionnaire or an application for review of Order No. 22-UI-188845 with the Employment Appeals Board (EAB). On April 22, 2022, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 22-UI-188845 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the appellant questionnaire response claimant submitted with her application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: Order No. 22-UI-188845, mailed to claimant on March 16, 2022, stated "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-188845 at 2. Order No. 22-UI-188845 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than April 5, 2022."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-188845 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-188845 was due by April 5, 2022. Because claimant did not file their application for review until April 22, 2022, the application for review was late. The appellant questionnaire response claimant submitted with her application for review indicates she did not receive Order No. 22-UI-188845 until March 30, 2021. EAB Exhibit 1 at 1. However, claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the April 5, 2022 deadline, or explaining why she did not file her application for review until April 22, 2022. Accordingly, claimant did not show good cause for the late application for review, and that she filed her late application for review within a reasonable time. Claimant's late application for review therefore is dismissed.

DECISION: The application for review filed April 22, 2022 is dismissed. Order No. 22-UI-188845 remains undisturbed.
