EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0639

Affirmed Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On December 2, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed a late claim for unemployment insurance benefits for the week of October 24, 2021 through October 30, 2021 (week 43-21) and was therefore denied benefits for that week (decision # 94557). On December 22, 2021, decision # 94557 became final without claimant having filed a request for hearing. On December 24, 2021, claimant filed a late request for hearing on decision # 94557. ALJ Kangas considered claimant's request, and on March 15, 2022 issued Order No. 22-UI-188644, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 29, 2022. On April 4, 2022, claimant filed a timely application for review of Order No. 22-UI-188644 with the Employment Appeals Board (EAB).¹ On June 2, 2022, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late.² This matter comes before EAB based upon claimant's application for review of Order No. 22-UI-188644.

FINDING OF FACT: (1) On December 2, 2021, the Department mailed decision # 94557 to claimant's address on file with the Department. The decision stated, in relevant part, "You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received no later than December 22, 2021." Exhibit 1 at 2.

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010

¹ Claimant's application for review did not include a response to the appellant questionnaire.

² Although claimant did not submit an appellant questionnaire response with his application for review, OAH treated claimant's April 4, 2022 application for review as an appellant questionnaire response.

(February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

On December 2, 2021, the Department mailed decision # 94557 to claimant's address of record on file with the Department. The 20-day deadline for claimant to file a timely request for hearing on decision # 94557 was December 22, 2021. Claimant did not file a request for hearing on decision # 94557 until December 24, 2021. As such, claimant's request for hearing was late.

In their December 24, 2021 request for hearing, claimant acknowledged that they were filing their request late, but explained, "[their] phone which is [their] computer was broken for about a week and a half and [they] had to use [their] brother's computer to look for work and [they] forgot about this paperwork at [their] house." Exhibit 2 at 2. However, taking measures to ensure that they did not forget about the December 22, 2021 deadline for filing a timely request for hearing on decision # 94557 was not a circumstance that was beyond claimant's reasonable control. Likewise, although forgetting about decision # 94557 was likely the result of a mistake on claimant's part, the record does not show that the mistake was an "excusable mistake" within the meaning of the administrative rules. The record does not, for example, raise a due process issue, and fails to show that any mistake was the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

Because the record does not show that factors beyond claimant's reasonable control or an excusable mistake prevented claimant from filing a hearing request by the December 22, 2021 deadline, claimant failed to establish good cause to extend the filing deadline beyond that date. Therefore, claimant's late request for hearing on decision # 94557 is subject to dismissal under ORS 657.875 and OAR 471-040-0010.

DECISION: Order No. 22-UI-188644 is affirmed.
