

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0645

Affirmed
Late Request for Hearing Dismissed
Overpayment Assessed

PROCEDURAL HISTORY: On May 21, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits from March 21 through May 15, 2021 because she was unable to work during that period (decision # 140815). On June 10, 2021, decision # 140815 became final without claimant having filed a request for hearing. On March 30, 2022, the Department served notice of and administrative decision based on decision # 140815, concluding that claimant was overpaid \$5,000 in Pandemic Emergency and Federal Pandemic Unemployment Compensation that would be deducted from any benefits payable during the following three-year period (decision # 161602). On April 18, 2022, claimant filed a late request for hearing on decision # 140815 and a timely request for hearing on decision # 161602. On May 16, 2022, ALJ Ramey conducted a hearing, and on May 18, 2022 issued Order No. 22-UI-194067 dismissing claimant's late request for hearing on decision # 140815, and Order No. 22-UI-194072 affirming decision # 161602. On June 6, 2022, claimant filed applications for review of Orders No. 22-UI-194067 and 22-UI-194072 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-194067 and 22-UI-194072. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0644 and 2022-EAB-0645).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Order No. 22-UI-194067 and 22-UI-194072 are affirmed.
