# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0653

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On January 19, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work during the week of May 31, 2020 through June 6, 2020 (week 23-20) and therefore was ineligible to receive unemployment insurance benefits during that week (decision #152845). On February 8, 2022, decision #152845 became final without claimant having filed a request for hearing. On February 9, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on May 12, 2022 issued Order No. 22-UI-193492, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 26, 2022. On June 1, 2022, Order No. 22-UI-193492 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On June 8, 2022, claimant filed an application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of the written statement claimant included with her application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

**FINDING OF FACT:** (1) Order No. 22-UI-193492, mailed to claimant on May 12, 2022 stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-193492 at 2. Order No. 22-UI-193492 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than June 1, 2022."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 22-UI-193492 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-193492 was due by June 1, 2022. Because claimant did not file her application for review until June 8, 2022, the application for review was late. Claimant provided a written statement with the application for review. Claimant's written statement indicates claimant received the order under review, misplaced the order shortly after she received it, and then forgot about it. As soon as claimant remembered, she located the application for review, filled out her written statement, and submitted it. Claimant receiving the order, but then misplacing and forgetting about the order for a period of time, while understandable, was a circumstance within claimant's reasonable control. Accordingly, claimant did not show good cause for her late application for review, and her late application for review is dismissed.

**DECISION:** The application for review filed June 8, 2022 is dismissed. Order No. 22-UI-193492 remains undisturbed.
