EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0655

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On July 19, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks including April 19, 2020 through April 3, 2021 (weeks 17-20 through 13-21) and therefore was denied benefits for those weeks (decision # 80930). On August 9, 2021, decision # 80930 became final without claimant having filed a request for hearing. On November 5, 2021, claimant filed a late request for hearing on decision # 80930.

ALJ Kangas considered claimant's request, and on February 22, 2022 issued Order No. 22-UI-186888, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 8, 2022. On March 14, 2022, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 22-UI-186888 with the Employment Appeals Board (EAB). On June 9, 2022, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's March 14, 2022 application for review of Order No. 22-UI-186888.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

CONCLUSIONS AND REASONS: Order No. 22-UI-186888 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 80930 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The request for hearing on decision #80930 was due by August 9, 2021. Because claimant did not file their request for hearing until November 5, 2021, the request was late. On their appellant questionnaire response, under the question asking when they received the administrative decision, claimant indicated that they were "denied after filed" and "only received [benefits] for 2 – 3 weeks then stopped." EAB Exhibit 1 at 2. It is not clear from this statement when, if at all, claimant received decision #80930 or otherwise learned about it. On remand, the ALJ should inquire as to when claimant received decision #80930, how they learned about the decision if they never received it, and in any case, what caused them to file the request for hearing months after the decision became final. Additionally, in a statement attached to the appellant questionnaire response, claimant indicated that they "have some disabilities [they have] had since [they were] very young in school," and that "all paperwork is very overwhelming to [them]. EAB Exhibit 1 at 4. This statement suggests that claimant might have a learning disability or other cognitive impairment which might have impacted claimant's ability to receive or understand decision #80930, including the instructions on how to appeal. On remand, the ALJ should inquire as to the nature of claimant's disability and how, if at all, it impacted claimant's ability to file a timely request for hearing.

Order No. 22-UI-186888 therefore is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 80930.

DECISION: Order No. 22-UI-186888 is set aside, and this matter remanded for further proceedings consistent with this order.
