

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0656

Affirmed
Late Request to Reopen Denied

PROCEDURAL HISTORY: On January 14, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks from March 8, 2020 through March 28, 2020 (weeks 11-20 through 13-20) and May 10, 2020 through November 14, 2020 (weeks 20-20 through 46-20), and therefore was denied benefits for those weeks (decision # 72132). Claimant filed a timely request for hearing. On February 8, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for February 22, 2022. On February 22, 2022, claimant failed to appear at the hearing, and on February 23, 2022 ALJ Ramey issued Order No. 22-UI-187018, dismissing the hearing request due to claimant's failure to appear. On March 15, 2022, Order No. 22-UI-187018 became final without claimant having filed a timely request to reopen the hearing. On April 4, 2022, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request, and on May 26, 2022 issued Order No. 22-UI-194755, denying the request as late without a showing of good cause, leaving Order No. 22-UI-187018 undisturbed. On June 1, 2022, claimant filed an application for review of Order No. 22-UI-194755 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-194755 is affirmed.
