EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0661

Reversed & Remanded

PROCEDURAL HISTORY: On November 18, 2021, the Oregon Employment Department (the Department) served Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits from February 2, 2020 through December 19, 2020 (weeks 6-20 through 51-20). On December 8, 2020, the PUA determination became final without claimant having requested a hearing. On January 10, 2022 claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on April 4, 2022, issued Order No. 22-UI-190479, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 18, 2022. On April 22, 2022, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 22-UI-190479 with the Employment Appeals Board (EAB). On June 9, 2022, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the appellant questionnaire was late, it would not be considered, another order would not be issued, and Order No. 22-UI-190479 remained in effect. This matter comes before EAB based on claimant's timely application for review or Order No. 22-UI-190479.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of the written statement claimant included with his application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDINGS OF FACT: (1) On November 18, 2021, the Department mailed a Notice of Determination for Pandemic Unemployment Assistance to claimant's address on file with the Department. The PUA determination stated, "You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received by December 8, 2021." Exhibit 1 at 2.

CONCLUSIONS AND REASONS: Order No. 22-UI-190479 is reversed, and this matter remanded to OAH for a hearing on whether claimant's request for hearing on the November 18, 2021 PUA determination should be allowed and, if so, the merits of that determination.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The deadline to file a timely request for hearing on the PUA determination was December 8, 2021. Claimant submitted a request for hearing on January 10, 2022. Therefore, that request for hearing was late. However, claimant stated in his application for review he filed a timely request for hearing on December 3, 2021. EAB Exhibit 1 at 1. Claimant's January 10, 2022 email to the Department also indicates he believed he previously filed a request for hearing, as the email seeks to "follow up" on a previous "request" to appeal what appears to be the PUA determination. Exhibit 2 at 2-5. These statements indicate that claimant may have timely filed the request for hearing or, alternatively, that claimant's failure to file a timely request for hearing was due to factors beyond his reasonable control or an excusable mistake, and that claimant filed his late request for hearing within a reasonable time. Order No. 22-UI-190479 therefore is reversed, and this matter remanded for a hearing on whether claimant's request for hearing should be allowed and, if so, the merits of the PUA determination.

DECISION: Order No. 22-UI-190479 is set aside, and this matter remanded for further proceedings consistent with this order.
