

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0665**

*Affirmed*  
*Late Request for Hearing Dismissed*  
*Overpayment Assessed*

**PROCEDURAL HISTORY:** On July 13, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective March 28, 2021 (decision # 151849). On August 2, 2021, decision # 151849 became final without claimant having filed a request for hearing. On April 1, 2022, the Department served notice of an administrative decision, based in part on decision # 151849, concluding that claimant received \$4,570 in Pandemic Emergency and Federal Pandemic Unemployment Compensation benefits to which he was not entitled and was required to repay to the Department (decision # 160732). On April 21, 2022, claimant filed a late request for hearing on decision # 151849 and a timely request for hearing on decision # 160732. On May 18, 2022, ALJ Ramey conducted a hearing on decisions # 151849 and 160732. On May 20, 2022, ALJ Ramey issued Orders No. 22-UI-194235 and 22-UI-194239, dismissing claimant's late request for hearing on decision # 151849 and affirming decision # 160732.

On June 9, 2022, claimant filed applications for review of Orders No. 22-UI-194235 and 22-UI-194239 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-194235 and 22-UI-194239. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0665 and 2022-EAB-0666).

**WRITTEN ARGUMENT:** Claimant did not declare that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 22-UI-194235 and 22-UI-194239 are affirmed.
