

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0667**

*Affirmed*  
*Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On October 9, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision assessing an overpayment of \$2,200 in regular unemployment insurance benefits to be offset against the amount claimant was eligible to receive on a new claim (decision # 153459). On October 29, 2020, decision # 153459 became final without claimant having filed a request for hearing. On January 13, 2021, claimant filed a late request for hearing on decision # 153459. ALJ Kangas considered claimant's request, and on January 28, 2021 issued Order No. 21-UI-159941, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 11, 2021. On February 4, 2021, claimant filed a timely response to the appellant questionnaire. On March 8, 2021, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 21-UI-159941 was vacated and that a new hearing would be scheduled to determine whether claimant had good cause to file the late request for hearing and, if so, the merits of decision # 153459.

On May 27, 2022, the Department served notice of decision # 81227, an administrative decision that cancelled decision # 153459. On May 31, 2022, ALJ Griffin issued Order No. 22-UI-194917, dismissing claimant's request for hearing on decision # 153459 because the Department had issued decision # 81227 and thereby resolved decision # 153459 by cancellation. On June 10, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB considered claimant's written argument when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-194917 is affirmed.
