

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0683

Affirmed
Late Request for Hearing Dismissed
Overpayment Assessed

PROCEDURAL HISTORY: On November 10, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not eligible to receive Pandemic Unemployment Assistance (PUA) effective June 28, 2020. On November 30, 2021 the November 10, 2021, administrative decision became final without claimant having filed a request for a hearing. On April 8, 2022, the Department served notice of an administrative decision concluding that claimant was paid \$2,121 in PUA and Federal Pandemic Unemployment Compensation (FPUC) benefits to which she was not entitled (decision # 101811). On April 26, 2022 claimant filed a late request for hearing of the November 10, 2021 administrative decision and a timely request for hearing of decision # 101811. On May 23, 2022, ALJ Monroe conducted a hearing, and on May 26, 2022 issued Order No. 22-UI-194807, dismissing claimant's late request for hearing on the November 10, 2021 administrative decision, leaving the November 10, 2021 administrative decision undisturbed. On June 13, 2022, ALJ Monroe issued Order No. 22-UI-196021 affirming decision # 101811.

On June 13, 2022, claimant filed an application for review of Order No. 22-UI-194807 with the Employment Appeals Board (EAB). On June 21, 2022, claimant filed an application for review of Order 22-UI-196021 with EAB. Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-194807 and 22-UI-196021. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0673 and 2022-EAB-0683).

EAB reviewed the entire hearing record in these cases. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 22-UI-194807 and No. 22-UI-196021 are affirmed.
