

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0688

*Application for Review of Order No. 22-UI-194616 Dismissed
No Justiciable Controversy*

PROCEDURAL HISTORY AND FINDINGS OF FACT: On January 13, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for St. Charles Health System Inc. with good cause and was not disqualified from receiving unemployment insurance benefits based on that work separation (decision # 145629). St. Charles Health System Inc. filed a timely request for hearing on decision # 145629. On May 18, 2022, the Office of Administrative Hearings (OAH) scheduled a hearing on decision # 145629 for June 2, 2022 at 8:15 a.m. On May 24, 2022, St. Charles Health System Inc. withdrew their request for hearing on decision # 145629, and on May 25, 2022, ALJ Wardlow therefore issued Order No. 22-UI-194616, dismissing St. Charles Health System Inc.'s request for a hearing on decision # 145629. On June 14, 2022, claimant filed an application for review of Order No. 22-UI-194616 with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 22-UI-194616 presents no justiciable controversy and is dismissed.

On June 14, 2022, claimant filed with the Employment Appeals Board (EAB) an application for review of Order No. 22-UI-194616, which dismissed St. Charles Health System Inc.'s request for hearing on decision # 145629 after St. Charles Health System Inc. withdrew their request for hearing on decision # 145629. Decision # 145629 had concluded that claimant quit working for St. Charles Health System Inc. with good cause and was not disqualified from receiving unemployment insurance benefits based on that work separation.

Claimant did not assign error to any portion of Order No. 22-UI-194616, did not request reversal of any portion of Order No. 22-UI-194616, and alleged no facts entitling claimant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review of Order No. 22-UI-194616. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 22-UI-194616 is dismissed, and Order No. 22-UI-194616 remains undisturbed.

DECISION: The application for review of Order No. 22-UI-194616 filed June 14, 2022 is dismissed. Order No. 22-UI-194616 remains undisturbed.
