EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0689

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On June 25, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision assessing an overpayment of \$195 in regular unemployment insurance benefits to be deducted from any benefits payable during the five-year period in which the decision became final, and an overpayment of \$600 in Federal Pandemic Unemployment Compensation (FPUC) benefits to be deducted from any benefits payable during the three-year period following the week in which the decision became final (decision #81026). On July 15, 2021, decision # 81026 became final without claimant having filed a timely request for hearing. On December 13, 2021, claimant filed a late request for hearing, which was construed by the Office of Administrative Hearings (OAH) as applying to decision #81026. ALJ Kangas considered claimant's request, and on March 7, 2022 issued Order No. 22-UI-187949, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 21, 2022. On March 16, 2022, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response, and on June 2, 2022, issued Order No. 22-UI-195217, cancelling Order No. 22-UI-187949 and re-dismissing claimant's request for hearing on decision #81026 as late without a showing of good cause. On June 15, 2022, claimant filed an application for review of Order No. 22-UI-195217 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

¹ It is not clear whether claimant intended to appeal decision #81026, as their request for hearing appears to have been related to decision #0560519, issued by the Department on December 8, 2021. EAB has taken notice of this information, which is contained in Employment Department records. OAR 471-041-0090(1) (May 13, 2019). Any party that objects to our taking notice of this information must submit such objection to this office in writing, setting forth the basis of the object ion in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the noticed fact will remain in the record. Decision #0560159, however, was cancelled by the Department's later issuance of decision #92358, and is therefore no longer in effect. Any request for hearing on decision #0560159 would therefore have been subject to dismissal for lack of a justiciable controversy. Because claimant did not indicate on their application for review that their request for hearing was intended to refer to decision #0560159, EAB accepts OAH's construction of the request for hearing as referring to decision #81026.

DECISION: Order No. 22-UI-195217 is affirmed.
