# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0698

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On April 1, 2022, the Oregon Employment Department (the Department) served notice of three administrative decisions denying claimant's weekly claims for benefits because the claims were late. Decision # 135317 denied benefits for the weeks from April 25 through May 1, 2021. Decision # 140248 denied benefits for the weeks from July 4 through 24, 2021. Decision # 140645 denied benefits for the weeks from August 22 through 28, 2021. Also on April 1, 2022, the Department served notice of administrative decision # 130110, concluding that claimant was denied benefits from July 25 through September 4, 2021 because she did not actively seek work during that period.

Claimant filed a timely request for hearing on all four administrative decisions. On May 9, 2022, ALJ Lucas conducted a hearing, and on May 11, 2022 issued Orders No. 22-UI-193443, 22-UI-193441, 22-UI-193440 and 22-UI-193439, affirming decisions # 135317, 140248, 140645 and 130110. On May 31, 2022, Orders No. 22-UI-193443, 22-UI-193441, 22-UI-193440 and 22-UI-193439 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 7, 2022, claimant filed a late application for review of Orders No. 22-UI-193443, 22-UI-193441, 22-UI-193440 and 22-UI-193439 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-193443, 22-UI-193441, 22-UI-193440 and 22-UI-193439. For case-tracking purposes, this decision is being issued in quadruplicate (EAB Decisions 2022-EAB-0699, 2022-EAB-0698, 2022-EAB-0697 and 2022-EAB-0696).

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence the written statement included with claimant's application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

**FINDING OF FACT:** (1) Order No. 22-UI-193443, mailed to claimant on May 11, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-193443 at 3. Order No. 22-UI-193443 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before May 31, 2022 to be timely."

- (2) Order No. 22-UI-193441, mailed to claimant on May 11, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-193441 at 3. Order No. 22-UI-193441 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before May 31, 2022 to be timely."
- (3) Order No. 22-UI-193440, mailed to claimant on May 11, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-193440 at 3. Order No. 22-UI-193440 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before May 31, 2022 to be timely."
- (4) Order No. 22-UI-193439, mailed to claimant on May 11, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-193439 at 3. Order No. 22-UI-193439 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before May 31, 2022 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Orders No. 22-UI-193443, 22-UI-193441, 22-UI-193440 and 22-UI-193439 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Orders No. 22-UI-193443, 22-UI-193441, 22-UI-193440 and 22-UI-193439 was due May 31, 2022. Because claimant did not file her application for review until June 7, 2022, the application for review was late. Claimant's application for review included a written statement. EAB Exhibit 1. However, claimant's written statement did not describe the circumstances that prevented her from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and her late application for review is dismissed.

**DECISION:** The application for review filed June 7, 2022 is dismissed. Orders No. 22-UI-193443, 22-UI-193441, 22-UI-193440 and 22-UI-193439 remain undisturbed.
