

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0723

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 25, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits beginning October 27, 2019 because she quit working for the employer without good cause (decision # 104403). Claimant filed a timely request for hearing. On December 28, 2020, ALJ Scott conducted a hearing and issued Order No. 20-UI-158272, affirming decision # 104403. On January 19, 2021, Order No. 20-UI-158272 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 27, 2022, claimant filed a late application for review with EAB.

FINDING OF FACT: (1) Order No. 20-UI-158272, mailed to claimant on December 28, 2020, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 20-UI-158272 at 3. Order No. 20-UI-158272 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before January 19, 2021 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 20-UI-158272 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-158272 was due January 19, 2021. Because claimant did not file her application for review until June 27, 2022, the application for review was late. Claimant’s

application for review did not include a written statement describing the circumstances that prevented her from filing the application for review by the January 19, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and her late application for review is dismissed.

DECISION: The application for review filed June 27, 2022 is dismissed. Order No. 20-UI-158272 remains undisturbed.
