

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0728

Affirmed

Ineligible for Pandemic Unemployment Assistance Weeks 17-20 through 28-20, and 14-21

PROCEDURAL HISTORY: On March 17, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits effective February 2, 2020. On April 6, 2021, the March 17, 2021 administrative decision became final without claimant having filed a request for hearing. On May 2, 2021, claimant filed a late request for hearing on the March 17, 2021 administrative decision. ALJ Kangas considered claimant's request, and on May 26, 2021 issued Order No. 21-UI-167507, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 9, 2021. On June 9, 2021, claimant filed a timely response to the appellant questionnaire. On August 23, 2021, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 21-UI-167507 was vacated and that a new hearing would be scheduled to determine whether claimant had good cause to file the late request for hearing and, if so, the merits of the March 17, 2021 administrative decision. On June 14, 2022, ALJ Scott conducted a hearing, and on June 15, 2022 issued Order No. 22-UI-196214, affirming the March 17, 2021 administrative decision by concluding that claimant was not eligible to receive PUA benefits for the weeks including April 19, 2020 through July 11, 2020 (weeks 17-20 through 28-20), and the week of April 4, 2020 through April 10, 2020 (week 14-21). On June 28, 2022, claimant filed an application for review of Order No. 22-UI-196214 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-196214 is affirmed.
