

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0729

Affirmed
Overpayment Assessed

PROCEDURAL HISTORY: On December 9, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received \$1,800 in Lost Wages Assistance benefits to which he was not entitled and that he was required to repay (decision # 0561143). Claimant filed a timely request for hearing. On May 10, 2022, ALJ Monroe conducted a hearing, and on June 14, 2022 issued Order No. 22-UI-196126, affirming decision # 0561143. On June 21, 2022, ALJ Monroe issued Amended Order No. 22-UI-196464 to correct an error in Order No. 22-UI-196126, but re-affirming decision # 0561143. On June 28, 2022, claimant filed an application for review of Amended Order No. 22-UI-196464 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-196464 is affirmed.
