Request to Reopen Denied~ La Aplicación Para Reabrir Es Negada

PROCEDURAL HISTORY: On January 20, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able, available, and actively seeking work and was therefore disqualified from receiving unemployment insurance benefits from January 2, 2022 through January 15, 2022. Claimant filed a timely request for a hearing. On February 15, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for February 25, 2022. On February 25, 2022, claimant failed to appear at the hearing, and ALJ Mott issued Order No. 22-UI-187361, dismissing claimant's request for hearing due to their failure to appear. On March 16, 2022, claimant filed a request to reopen the hearing. ALJ Kangas considered the request, and on June 8, 2022 issued Order No. 22-UI-195626, denying the request, leaving Order No. 22-UI-187361 undisturbed. On June 28, 2022, claimant filed an application for review of Order No. 22-UI-195626 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information into the hearing record with her request to reopen the hearing, as required under OAR 471-040-0040(3) (February 10, 2012). Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into the hearing record when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.
