Late Claims for Benefits Denied

PROCEDURAL HISTORY: On July 6, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks from December 27, 2020 through February 20, 2021 and therefore was denied benefits for those weeks (decision #113646). Also on July 6, 2021, the Department served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks from February 21 through March 27, 2021 and therefore was denied benefits for those weeks (decision #14049). Also on July 6, 2021, the Department served notice of an administrative decision concluding that claimant filed a late claim for benefits for the week of April 4 through 10, 2021 and therefore was denied benefits for that week (decision #114429). Also on July 6, 2021, the Department served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks from April 18 through May 8, 2021 and therefore was denied benefits for those weeks (decision #114710). Also on July 6, 2021, the Department served notice of an administrative decision concluding that claimant filed a late claim for benefits for the week of May 30 through June 5, 2021 and therefore was denied benefits for that week (decision #114932).

Claimant filed timely requests for hearing on decisions # 113646, 114049, 114429, 114710, and 114932. On April 21, 2022, ALJ Logan conducted a hearing, and on April 22, 2022 issued Orders No. 22-UI-192016, 22-UI-192015, 22-UI-192014, 22-UI-192012 and 22-UI-192013, affirming decisions # 113646, 114049, 114429, 114710, and 114932. On April 25, 2022, claimant filed applications for review of Orders No. 22-UI-192016, 22-UI-192015, 22-UI-192014, 22-UI-192012, and 22-UI-192013 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-192016, 22-UI-192015, 22-UI-192014, 22-UI-192012 and 22-UI-192013. For case-tracking purposes, this decision is being issued in quintuplicate (EAB Decisions 2022-EAB-0373, 2022-EAB-0374, 2022-EAB-0375, 2022-EAB-0377, and 2022-EAB-0376).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond her reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13,

2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Order Nos. 22-UI-192016, 22-UI-192015, 22-UI-192014, 22-UI-192012, and 22-UI-192013 are affirmed.
