# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0752

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 24, 2013, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective November 18, 2012 (decision #74519). On May 14, 2013, decision #74519 became final without claimant having filed a request for hearing. On May 8, 2015, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on May 18, 2015 issued Order No. 15-UI-38656, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 1, 2015. On June 1, 2015, claimant filed a timely response to the appellant questionnaire. On June 19, 2015, ALJ M. Davis conducted a hearing and issued Order No. 15-UI-40342, dismissing claimant's request for hearing as late without good cause, leaving decision #74519 undisturbed. On July 9, 2015, Order No. 15-UI-40342 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On May 24, 2022, claimant filed a late application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

**FINDING OF FACT:** (1) Order No. 15-UI-40342, mailed to claimant on June 19, 2015, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 15-UI-40342 at 4. Order No. 15-UI-40342 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 9, 2015 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 15-UI-40342 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 15-UI-40342 was due July 9, 2015. Because claimant did not file their application for review until May 24, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed May 24, 2022 is dismissed. Order No. 15-UI-40342 remains undisturbed.
